2. Shares earned based on achieving certain 2023 performance targets. The shares will vest 6.25% quarterly retroactively from 2023 over a four year period. The Reporting Person has voting and dividend rights on all of these shares, including unvested shares.
3. The shares will vest 6.25% quarterly beginning in 2024 over a four year period. The Reporting Person has voting and dividend rights on all of these shares, including unvested shares.
